

OFF-STREET PARKING PROPOSALS – INVERURIE

"The Aberdeenshire Council (Off-Street Parking) Order 2019, Amendment No.3 Order 2024"

Aberdeenshire Council provide off-street parking places to relieve or prevent on-street congestion in settlements however these spaces are costly to provide, manage and maintain. The proposed order would see pay and display charging introduced to the Burn Lane (North End) Car Park, Invertige to help cover these costs.



OFF-STREET PARKING - INVERURIE

"The Aberdeenshire Council (Off-Street Parking) Order 2019, Amendment No.3 Order 2024" is being proposed under the Road Traffic Regulation Act, 1984.

The effect of the order will be to introduce pay and display parking in Burn Lane (North End) Car Park in Inverurie.

ROAD TRAFFIC REGULATION ACT, 1984

THE ABERDEENSHIRE COUNCIL (OFF-STREET PARKING) ORDER 2019, AMENDMENT NO.3 ORDER 2024
