As part of the ongoing exercise to identify potential savings, it is proposed that the annual recharge that the T&EB team receives is increased to meet the costs of 4 FTE posts (2 FTE posts are currently funded via this recharge). This increase will be funded via employer savings arising from the salary sacrifice schemes, which the Team administer.
