“The Aberdeenshire Council (Off-Street Parking) Order 2019, Amendment No.2 Order 2024” is being proposed under the Road Traffic Regulation Act, 1984.

OFF-STREET PARKING PROPOSALS – BANFF SND FRASERBURGH

“The Aberdeenshire Council (Off-Street Parking) Order 2019, Amendment No.2 Order 2024”

Aberdeenshire Council provide off-street parking places to relieve or prevent on-street congestion in settlements however these spaces are costly to provide, manage and maintain. The proposed order would see pay and display charging introduced to the currently free spaces at St Mary’s Car Park in Banff and the Hanover Street (South) Car Park in Fraserburgh, to help cover these costs.

THE ABERDEENSHIRE COUNCIL (OFF-STREET PARKING) ORDER 2019, AMENDMENT
NO.2 ORDER 2024

Aberdeenshire Council in exercise of the powers conferred upon it under the Road Traffic Regulation Act, 1984, and of all other enabling powers, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 of the Act of 1984, hereby makes the following order:-

1. This order may be cited as “The Aberdeenshire Council (Off-Street Parking) Order 2019, Amendment No.2 Order 2024”, and shall come into operation on
2. Schedule 1, Table A of the “The Aberdeenshire Council (Off-Street Parking) Order 2019” shall be amended by replacing “St Mary’s (West)” with "St Mary’s (East and West)" and replacing "Hanover Street (South)" with "Hanover Street (South - all spaces)".
3. The entries for “St Mary’s (East)" and "Hanover Street (South)” specified in Schedule 1, Table B of the “The Aberdeenshire Council (Off-Street Parking) Order 2019” shall hereby be removed.
